Glendale Coin Club Coin & Paper Money Show Bourse Rules

- 1. The Glendale Coin Club Coin & Paper Money Show will be held on Sunday, October 25, 2015 at the Van Nuys Masonic Hall, located at 14750 Sherman Way, Van Nuys, CA. Dealer setup starts at 8 AM on the day of the show, and dealers can deal between themselves at that time. The Show will open to the public at 10:00 AM and close at 5PM.
- 2. Bourse space consists of one 8-foot table with a backup table. Prior to June 1, 2015, bourse fees are \$100 for a single table & \$95 for each additional table. Starting May 1, 2015, fees will be \$110 for a single table & \$100 for each additional table. Your bourse fee includes: (1) Sign for the bourse space with the dealer's name and city listed; (2) A one-year membership in the Glendale Coin Club (3) A Hourly Silver Drawing ticket. Sharing of space must be approved by the Bourse Chairman prior to the show.
- 3. A security guard will be on the premises continually from 8 AM through 6 PM on the day of the show. Due caution and protection will be exercised, but the Glendale Coin Club, it's officers, members or committees, shall not be held responsible for any loss or damage suffered by any dealer.
- 4. Applications for bourse space should be made as soon as possible. Full payment must be made with the application. Spaces will be assigned approximately two weeks prior to the show. If a dealer is unable to attend the show, their bourse fee will be refunded, provided the Bourse Chairman is notified at least three weeks prior to the show. Refunds for last minute cancellations will depend upon the reselling of the space.
- 5. Complimentary coffee and donuts will be available for the dealers during dealer setup. Lunch, snacks and beverages will be available for purchase at time of application and during the Show, subject to availability.
- 6. Dealers agree to abide by all of the City of Los Angeles, County of Los Angeles, State of California and United States Laws and Regulations.
