## **Glendale Coin Club Coin & Paper Money Show Bourse Rules**

1. The Glendale Coin Club Coin & Paper Money Show will be held Sunday, October 23, 2011 at the Van Nuys Masonic Hall, 14750 Sherman Way, Van Nuys, CA. Dealer set up starts at 8 AM on the day of the show, & dealers can deal between themselves at that time. The show will open to the public at 10 AM & close at 4PM.
2. Bourse space consists of one 8-foot table with a backup table. Bourse fees are \$100.00 for a single table & \$95.00 for each additional table(s). Your bourse fee also includes: (1) Sign for the bourse space with the dealer's name & city listed; (2) A one year membership in the Glendale Coin Club. Sharing of a space must be approved by the Bourse Chairman prior to the show.
3. A security guard will be on the premises continually from 8 AM to 5 PM on the day of the show. Due caution & protection will be exercised, but the Glendale Coin Club, its officers, members, or committees, shall not be held responsible for any loss or damage suffered by any dealer.
4. Applications for bourse space should be made as soon as possible. Spaces will be assigned two weeks before the show. If a dealer is unable to attend the show, their bourse fee will be refunded provided the Bourse Chairman is notified at least two weeks prior to the show. Refunds for last minute cancellations will depend on reselling of the space.
5. Complimentary food & beverages will be available at the beginning of the show. Lunch, snacks & beverages will be available for purchase once the show opens to the public.
6. Dealers agree to abide by all of the City of Los Angeles, County of Los Angeles & State of California laws.
